### Implementation issues including impact on your systems

No system changes are required as part of this proposal.

#### **Additional Information and Comments**

British Gas Supports this modification.

We believe that 10 days is an adequate time period for allowing reads to be exchanged between parties.

Guaranteed longer meter read window facilities greater volumes of actual reads through the Change of Supply process. The extended window ensures that any correct reads that fail validation are more likely to be amended in time. We believe this is good for the industry and good for customers.

Furthermore this proposal promotes efficient administration of the code by aligning the UNC 0427 modification proposal to the IGT UNC 048 code proposal.

This modification proposal brings into code industry practice of accepting reads up to 10 days. This mitigates the risk to industry parties of future changes that may restrict the acceptance of files to 7, 8 or 9 days.

Any changes to the current window will require system changes and increase costs to Shippers as a consequence, with little to no gain.
