1. Plain English Summary

Is this a Self-Governance Modification?

Yes – and subject to the Ancillary Document change procedures under K43.3 and K43.4, requiring a panel majority for approval. The change is a minor change that is required quickly in order for SMU files to be sent over IX.

If so, will this be progressed as a Fast Track Modification?

Rationale for Change

On 31st July, Xoserve made the proposer aware of a minor change required to the iGT047 Ancillary Document - Data Items Relevant to Smart Metering File Flows, in order for SMU files to be sent successfully over IX. Without this change, files would not transmit.

Solution

The solution is to change the "Environment" in the File Naming Convention (page 4) from "02" to "01".

Relevant Objectives

The proposer believes this change better facilitates Objective D (Securing of effective competition between relevant shipper and suppliers). Without this change, shippers would not receive up to date 'smart relevant' information and would therefore not be able to provide the level of service customers expect.

Implementation

In spite of the fact that this modification may require parties to make a minor system change, it is required in order for these SMU files to be sent and received successfully by iGTs and shippers. The proposer requests/recommends as early an implementation date as possible. Modification Proposal iGT047 which includes the Ancillary Document is scheduled for implementation in a release of the iGT UNC on the 1st October 2014. Unless this change is approved parties will be working with an incorrect value in the Environment field.

2. Rationale for Change

As part of the iGT047 modification, iGTs and shippers agreed to send and receive SMU files over IX (Xoserve's file exchange network). In order for files to be successfully transmitted, the file format needs to be compatible with IX.

On 31st July, Xoserve made the proposer aware of a minor change required to the value for the Environment field in the File Naming Convention of the iGT047 Ancillary Document, in order for SMU files to be sent successfully over IX. Without this change, files would not transmit. When the latest version of the Ancillary Document was agreed, there was an expectation that this value may change and was subject to confirmation by the Service Provider (xoserve).



3. Solution

The solution is to change the "Environment" in the File Naming Convention (page 4) from "02" to "01".

The reference to "*the Node will be subject to confirmation from the Service Provider" will now also be removed, as this confirmation has now been received.
